DEVELOPMENT REGION	DevelopmentRegion	An aggregation of all the BC Regional Districts. The 8 Developmental Regions in BC have the same boundaries as the Economic Regions observed by Statistics Canada.
REGIONAL DISTRICT	RegionalDistrict	The British Columbia's regional districts by the Ministry of Community, Sports and Cultural Development under the local governmental legislations and regulations.
MUNICIPALITY	Municipality	Referring to British Columbia's municipalities and cities. The municipality is taken from BC Assessment jurisdictions. When data is not available the field defaults to the Municipal selection made on the property transfer tax form.
